6. The quoted amount shall have to be written both in figure & in words in English language only duly signed by the Agency Concerned.
7. Before participation, the agencies are requested to visit the site and examine the Repairing Work required to be completed. Only after that they are suggested to quote the rates against each items. Change of quantities or filled rates will not be considered afterwards.
8. **Earnest Money** : EMD to be paid @2% of the quoted amount by Demand Draft drawn in favour of SBI A/C ESIC, payable at Kolkata. The EMD should be attached with the offer at the time of dropping the tender, failing which the tender of the concerned agency will be treated as cancelled.
9. **Time Limit** : In case of delay, there will be deduction for an amount of 1.25% of the total cost of the work for every week of delay or part thereof as liquidated damages subject to a maximum of 5% of the cost of the work.

Tender may be dropped in the Tender Box kept at Regional Office Building (1<sup>st</sup> floor), E.S.I Corporation, 5/1 Grant Lane, Kolkata-700 012 or may be received by post within time period. Corporation will not be responsible for any postal delay. Tender shall be opened in presence of participants or their authorised representatives, if any.

Security Money @ 10% of the Order Value in the form of Demand Draft / Bankers cheque is to be submitted by the successful bidder within 07 days of issue of Work Order failing which the Work Order may liable to be cancelled. The Security Money will be returned after one year from the date of successful completion of work.

The Corporation reserve the right to change the scope of work and reject any or all tenders without assigning any reason therefor. The Corporation is also not bound to accept the lowest bidder if not submitted as per our descriptions stated in the tender paper.
