- 5) **Date & time of opening of tender** : **At 15.00 Hrs on 05.01.16**
- 6) **Performance Security** : *Security Money @ 10%* of the Order Value in the form of Demand Draft / Bankers cheque / Bank Guarantee is to be submitted by the successful bidder within 07 days of issue of Work Order failing of which the Work Order may be liable to cancel. - 7) Envelope containing the tender must be sealed and duly subscribed with the particular NIT No and name of work along with forwarding letter.
- 8) The quoted amount shall have to be written both in figure & in words in English Language only with the signature of the agency. The rate should be inclusive of all taxes & duties (VAT/ED/Service tax/labour welfare cess etc, if applicable)
- 9) Before quoting the tender and participation , the agencies are requested to visit the site and examine the quantities briefly. Only after that they are suggested to quote the rates .
- 10) **Eligibility Criteria** – The agency must have experience in respective field for which they are intended to apply. In support of which documentary proof has to be submitted along with the tender document. ESIC, EPF Registration certificate along with valid Lift and Trade licence may be submitted with tender document.
- 11) **Payment Terms.**- 100% payment will be made after satisfactory completion & handing over of work. No advance payment will be made against delivery of material .

The work has to be completed within stipulated time period from the date of issue of work order. In case of failure to complete the work as per terms & condition and within specified time schedule mentioned in the tender paper the ESIC would have the right to invoke penalty as per standard norms of contract i,e **@ 1.25 % of the total work value for every week of delay or part there of as L.D subject to a maximum of 5 % of the cost of work .**
