NOTE :

1. Result of Paralympics discipline will be declared later by the Hqrs. Office.
2. Result of Kabaddi (UDC), Kabaddi (MTS), Badminton (UDC, Men), Archery (UDC, Men) and Archery (MTS) dsicipline will be declared later by the East Zone Sports Control Board.
3. Candidates who is declared successful in more than one zone and / or for more than one post (UDC and MTS), he / she will submit an undertaking regarding his / her choice of post (UDC or MTS) and zone and state (choice of 3 states will be sought) of posting within 07 days after publication / declaration of Result in each zone. If declaration of concerned selected candidates is not received within stipulated time, we may allot him that zone according to his / her online filled address (under which his / her states comes) and UDC post if he is selected for both the post (UDC and MTS). Their choice of state does not confer him / her any right to claim of posting in those states he / she has chosen and allotment of posting / region will be done as per his / her ranking and availability of vacancies and in case of non availability of vacancies in their choice of States (preference of 03 states will be sought), the competent authority may allot him / her nearby state in which vacancies are available.
4. If posts remain vacant due to not joining of first list of selected candidates, supplementary result will be declared from the list of Reserve Panel of candidates in order of merit as per requirement of the Corporation.
5. Candidates may kindly note that those who have been allowed provisionally in various zones, don't submit required documents within 7 days times from the publication of result, their candidature will be cancelled and no further correspondence in these regards will be done in future and those who are just below in the merit in the Reserve List will be declared successful.
6. The candidature of the all candidates is provisional subject to verification of their original certificates in support of qualification, age, community / casts, experience as claimed, NOC etc. up to the satisfaction of the Appointing Authorities.
7. While every care has been taken in preparing the above Result, the ESI Corporation reserve the right to rectify / error / omission, if any at later stage.
